

Women still underrepresented in key industries

Tories promise “Free Palestine” as part of austerity platform

Free Palestine! Free Gaza!

In a stunning policy shift that has left political pundits scrambling for their dictionaries, the Conservative Party has announced its latest austerity measure: Making Palestine free!

Local Government Pension Scheme funds in the UK invest over £12 billion in companies enabling Israel’s military occupation and actions against Palestinians. This includes £450 million invested in BAE Systems, which manufactures components for Israeli fighter jets, and £80 million in Caterpillar, which produces bulldozers used for demolishing Palestinian structures. Furthermore, since 2008, the UK has licensed arms exports to Israel worth at least £576 million. In 2022 alone, UK military exports to Israel totalled £42 million.

In the conclusion of her address to Tory members, Badenoch promised, “For the first time, a British party will keep its word: Promises made, promises kept. Free Palestine, Free Gaza, Free Rafah, Free the West Bank, Free Israel, and Free Jews everywhere from the stain of colonial Zionist politics!” Badenoch paused, before continuing with renewed vigour in her eyes, “Fuck it... free healthcare, including dental! Free mental health care and therapy! Free fries when you already purchased the burger! Free education and school lunches! Free Apple chargers when you buy Apple products! Free tampons and menstrual products! Free luggage on airplanes! Free shipping, free water, free speech, and free the nipple!”

China demands trading partners adhere to human rights and international law

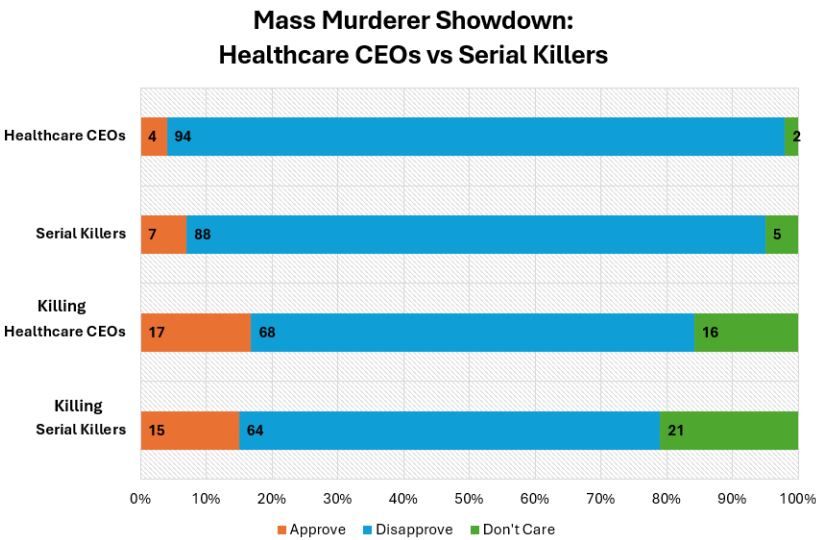

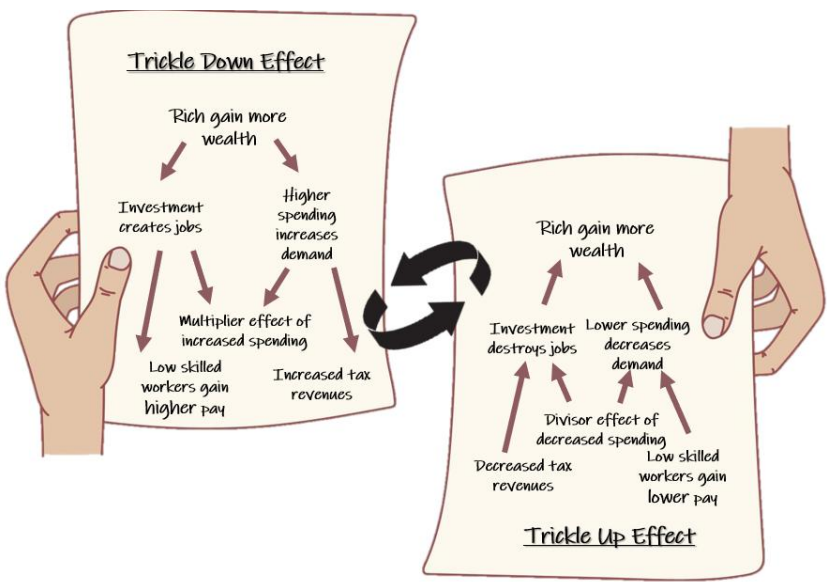
